NOTICE:

An individual who commits a civil or criminal traffic violation resulting in death or serious physical injury is not eligible to attend a defensive driving school, except that the Court may order the individual to attend a defensive driving school in addition to another sentence imposed by the Court on an adjudication or admission of the traffic violation.

WARNING:

To all persons under the age of 18:

You **must** appear in Court with a parent or legal guardian. If you fail to appear for any Court appearance, or fail to comply with any Court order, the Court will direct MVD to suspend your drivers license or driving privilege until you have satisfied the Court order or until your 18th birthday.

RED LIGHT VIOLATIONS:

A.R.S. §§ 28-645 or 28-647

If you are cited for either of these offenses and you are eligible, you may attend Defensive Driving School. If you are not eligible to attend Defensive Driving School, or if you choose not to attend Defensive Driving School and you are convicted of or enter a plea of responsible, the Motor Vehicle Division will send you a notice ordering you to attend and successfully complete Traffic Survival School.

INSURANCE VIOLATIONS

A.R.S. §§28-4135 (A), (B), (C)

****NEW CHANGES EFFECTIVE SEPTEMBER 30, 2009**

The statute allows the court to reduce the penalty imposed for a violation of A.R.S. §28-4135 if the person provides proof of BOTH of the following items: Defendant to obtain a 36 month driving history from MVD, and the purchase of a six month insurance policy that meets the requirements of A.R.S. §28-4009.

OPTION #2:

1. **READ AND SIGN** the following statements:

I hereby waive my rights to a hearing and enter a plea of responsible and consent to judgment imposing the prescribed fine.

2. Write the complaint number from the Arizona Traffic Ticket and Complaint located in the upper left-hand corner.

3. Match each violation code on your complaint to the codes listed on the Fine/Sanction Schedule. Pay the amount under the "Fine Amount" column if you are paying the ticket **BEFORE** the Court date written to the right of your signature on the complaint. Enter the amount for each charge you are paying, add fines, and then total.

4. Cut out this option and mail it with a copy of your citation, and money order or Cashers Check in the amount listed above, payable to Florence Municipal Court.

***DO NOT SEND CASH.**

*** If you are paying AFTER the date written on the ticket, DO NOT PAY. You MUST appear in Court as a warrant may have been issued for your arrest and/or your driver's license may have been suspended with additional penalties being imposed.**

**OPTION 3:
Request a Hearing**

You must request a hearing to contest the charges.
You cannot have a hearing on your initial appearance date.

1. READ AND SIGN the following statement:

I hereby request a hearing to contest the charges indicated below. I hereby enter my plea of not responsible. I understand I am giving up the option of attending a Defensive Driving Class for those charges for which I have requested this hearing.

2. Write the complaint number from the Arizona Traffic Ticket and Complaint located in the upper left-hand corner.
