Questions and Answers

<u>Question</u>: Would you be able to provide me with an estimate of the space's share of utilities?

Answer: Approximately \$2,500 per year for electric and water

<u>Question</u>: Please confirm the monthly rental amount and the amount of the security deposit.

<u>Answer</u>: Section 5.314 of the Property Lease Policy states "A security deposit of no less than one month rent is paid by the tenant upon approval of the lease by the Town Council. The deposit may be increased or decreased depending on the type of business, length of lease and information in the business plan." Section 5.315 states "Lease rental rates at the Silver King Marketplace range from @2.50 to \$6.00 per square foot for retail businesses. Rent for non-retail businesses is \$6.00 to \$10.00 per square foot."

<u>Question</u>: Is use of the "veranda" just outside the space available for casual seating? <u>Answer</u>: The veranda is currently closed for repairs. Once the repairs have been made, the veranda will be open to the public.

<u>Question</u>: Is it reasonable to expect that the lease will be renewed if all goes well or is there a limit on total length of tenancy?

Answer: There is no time limit on the total length of tenancy.

<u>Question</u>: Is there a requirement that the business housed by the space be open a minimum amount of hours per day, days per week or whether it is possible to "close for vacation"?

<u>Answer</u>: Tenants are required to be open 35 hours per week. Any extended closures must be approved by Town staff.

<u>Question</u>: Is the tenant allowed to sublet a fraction of the space? <u>Answer</u>: Subletting is not allowed. Additional services may be allowed subject to approval by Town staff.

<u>Question</u>: Regarding #4, may I submit my resume which includes other projects I have developed and worked on successfully? Answer: Yes, you can submit your resume. <u>Question</u>: Regarding # 5, Is a full credit report required or just a FICO score? Since I have not rented commercial space in over 18 years, may I submit my residential mortgage payment history in lieu? If not, may I strengthen my proposal by putting a certain number of months' rent in escrow?

<u>Answer:</u> Include your FICO score in the narrative that describes how the business will be financed. You can include any relevant information about prior commercial and residential leases in the narrative. An escrow account is not necessary.

<u>Question</u>: Do I see plumbing pipes in the rear interior of the space that would support a sink? If so, may I install one?

Answer: There is plumbing for a sink that can be installed as a tenant improvement.

<u>Question</u>: Is Padilla Park available for outdoor events hosted by the business with a few weeks' prior notice and subject to availability?

<u>Answer:</u> Yes, the Community Services Department manages the park so activities are scheduled through them.

<u>Question</u>: Would it be possible to put a small love seat/bench just outside the door and up against the wall? I note that the adjacent door opens in an outward direction, so it would not be obstructed.

Answer: A small bench would be permissible.

<u>Question:</u> Is there WIFI? What company/companies provide(s) internet service? <u>Answer:</u> Wifi is available in the building and along Main Street through Airebeame.
