#### **BACKGROUND/DISCUSSION:**

Cavass of the votes must be done not less than six days, nor more than 20 days, after a primary or general election, the Town will meet to canvass the votes. August 12, 2024, is 13 days after the Primary Election. Pinal County is also scheduled to canvass the votes on Friday, August 12, 2024.

When the results of the canvass are determined, the Town Clerk must enter upon the records a statement known as the official canvass, which must state the following:

The total number of ballots cast at said primary election, as shown by the poll lists or reported by the county, was 3720. The total number of registered voters for the Primary Election was 10,158. Thus, the voter turnout for the Primary Election was 36.62%

#### **Discussion on Steps Moving forward:**

Tracy Florea has officially withdrawn her candidacy from the upcoming Town Council election. Her withdrawal letter was received on August 4, 2024, via email. In her correspondence, Ms. Florea also indicated that she no longer resides within the municipal boundaries of the Town of Florence. As a result, although the votes are currently being canvassed, she is no longer eligible to serve on the Town Council.

Given the complexities and nuances of this situation, especially with statutory guidelines being somewhat vague, I have collaborated closely with the Town Attorney and consulted with several agencies including the County Recorder, County Attorney, other town and city clerks, and the Secretary of State's office since receiving the notice of her withdrawal.

As per the current statutory framework, the vacancy on the Town Council will not formally exist until the new term begins. This means that on December 9, 2024, when the new Council is officially seated, the vacant term will become effective. At the December 9, 2024 Special Council Meeting, after the selection of a Vice-Mayor, the Council will deliberate on how they would like to address the appointment to fill the vacant term.

At that time, Town staff will provide a more detailed briefing on the process for making the appointment and discuss the implications for future terms of office.

#### A VOTE OF NO WOULD MEAN:

A No vote means that the Town of Florence must reconvene to canvass the vote before August 19, 2024.

#### A VOTE OF YES WOULD MEAN:

A Yes vote means that the Town has accepted the results of the July 30, 2024 Primary Election.

#### **FINANCIAL IMPACT:**

There is no fiscal impact in approving the results of the 2024 Primary Election.
